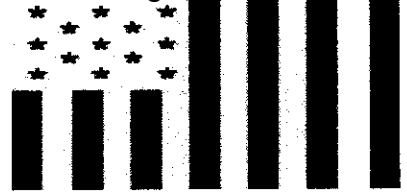

FINAL NOTICE**

**You are about to stipulate, admit and confess to false imprisonment, securities fraud, bankruptcy fraud and mail fraud and the notary public at Legal Registries shall certify your admission, confessions and stipulations to same.**

Further, you are about to execute a contract, stipulating to the terms and conditions stated below.

Any act, actions and/or communication in this matter other than the dismissal of this action and/or your failure to vacate the restrictions on the liberties of the Real Party In Interest and make the return of the property to the principal within the confines of the Regulation Z and the Truth In Lending Act, shall constitute execution of the contract and your stipulation to all terms and conditions set forth herein, to wit:

Upon execution of this contract Respondant consents and agrees to:

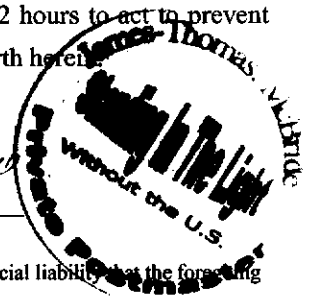
- a) The payment of an initial entry fee of \$20 million in gold coin for each count on the charging sheet;
- b) The payment of a fee in the amount of \$5 million in gold coin for each 'hearing' scheduled;
- c) The payment of a fee in the amount of \$1 million in gold coin for every communication;
- d) The payment of a fee in the amount of \$10 million in gold coin for taking possession, in any manner, of the body of the Real Party Of Interest;
- e) The payment of a fee in the amount of one (1) troy ounce of fine gold or gold coin for every 60 seconds the liberties of the Real Party Of Interest are restricted in any manner;
- f) Provide payment for all fees immediately upon creation of the fee to the Real Party In Interest;
- g) Agree to the filing of a NOTICE OF LIEN/ MEMORANDUM OF JUDGMENT into the public record against any/all equity claims in the name of and/or in the control of this Court, Clerk of Court and/or 'judge' and/or this Court's Corporate Charter and/or any/all performance bonds associated therewith;
- h) Agree to the immediate attachment and arrest of the performance bonds of all parties upon failure to immediately provide payment as agreed;
- i) Consent to the filing of said MEMORANDUM OF JUDGMENT into this case as a superior judgment;
- j) Consent to the execution of writ(s) of Enforcement and/or any appropriate writ(s) to facilitate the collections of said agreed upon fees;
- k) Agree to the reporting of said Notice Of Lien to all major credit reporting agencies.

In the event that this is simply an oversight, we, acting in good faith, extend you an additional 72 hours to act to prevent execution of said contract and certification of said admissions, confessions and stipulation as set forth hereon.
