Dear Judge Panner,

Just two weeks into January 1951 my dad, at 41 years of age, was managing a logging crew for Antone Haas in the timber forests of Northwest Oregon near Elsie. Lumberjacks had cut down trees, trimmed them and the Cat driver on the D-12 with an arch was picking up the logs to bring them to where the donkey would load them onto logging trucks. As it was described to our family dad was standing the prescribed distance away from the logging operation as the cat driver began to pull another log with the arch. However, he had not raised the butt end of the log high enough in the arch to clear the stump. Another logger was facing my dad and did not see the butt end of the log catch the stump and begin swinging like a long deadly gate. Without a moment's hesitation my dad rushed to the man and threw him out of the way as the log caught my dad and instantly crushed him. Tragically, the man whose live was spared never was able to come to terms that my father willingly gave his life to save him and he died some years later in a mental hospital.

Dad lived a life that can best be described as one who, when faced with a need, would do his best, without hesitation, to fulfill it. Was my dad wrong to act to save that man without a second thought? It was his pattern of life. My dad accepted people by their word. When he gave his word, he always kept it. When faced with a need that he could help with, he did so without hesitation.

Even as a young boy of ten my dad's life had left an indelible impression on me. I have lived my life responding to the needs of others. I do not seek out those in need to help, but when I have helped anyone who comes to me in a particular need they tell others and dozens more come to me to help them.

I take people at their word. The Lord has placed me in the position to learn facts that very few others seem to have been made privy to. When I receive information from one agency or official office I seek to verify with other sources. When someone comes to me for help I share what I have learned and verified. I take careful steps to make certain what I have learned is true and correct.

I do not seek out individuals to help. For those who come to me I make it clear when I share what I have learned that they are responsible for how they use this information and the need for each to verify it for himself.

I am learning some hard lessons. I live in a different world than the one my dad lived in. I am learning to be much more cautious in believing what people tell me. I can no longer be a simple, trusting individual who takes people at their word. It appears I can rarely take the word of anyone at face value. I am learning the only one who I can totally trust to be truthful is God Himself.

I am learning that it is not enough to simply share what I have been told. I am finding there are individuals who, if they do not like what I share...no matter how true it is, will attack the one who shared it.

As my dad lived his life I intend to continue to live my life in truth helping those who come to me with their needs. My prayer is that I would be like Paul, the Apostle, who said, "I have learned in whatever state I am therein to be content."

For both Beverly and myself our family roots and spiritual heritage go deep in northwest Oregon and western Washington. My parent's graves are in the Clatskanie Cemetery, our daughter, BeAnn, son in law and family live in the Tualatin Valley west of Portland. My sister, Roberta Bowman, lives in Gresham near her daughter, son in law, and family. Our niece, Candace Tompkins, and her husband, Mike, and sons live near Dayton, Oregon. In everything each of them has faced, I have seen in them that same deep faith and trust both our parents and grandparents instilled in us.

As the song writer put it, "I know not what the future holds, but I know Who holds the future..." For anything I may have done wrong my God has forgiven me. I trust you will do the same.
