ORDER

The Defendant Wesley Trent Snipes has recently filed the following motions: (1) Defendant Snipe's Motion to Compel Immediate Disclosure of Brady & Giglio Discovery Known to the Government (Doc. 237); (2) Defendant Snipes' Motion to Compel Immediate Disclosure of Government Witnesses and Potential Witnesses (Doc. 238); (3) Defendant Snipes' Motion to Compel Immediate Disclosure of Potential Incapacity or Credibility Deficiencies as to Prospective Government Witnesses (Doc. 239); (4) Defendant Snipes' Motion to Compel Immediate Disclosure of All Agents' Rough Notes of All Witness Interviews (Doc. 240); (5) Defendant Snipes' Motion to Compel Immediate Disclosure of All Statements of the Defendants and Alleged Co-Conspirators Including Any Statements Attributed to Them as Alleged Co-Conspirator Statements (Doc. 241); (6) Defendant Snipes' Motion to Compel Immediate Disclosure of Reasons For Bias of Any Potential Government Witness (Doc. 242); (7) Defendant Snipes' Motion to Compel All Jencks Statements To Protect the Due Process Rights of the Defendant (Doc. 243); (8) Defendant Snipes' Motion to Compel Immediate Disclosure of All "ARL" Clients Identities and IRS

Information Related to Those Clients Known to the Government (Doc. 252); and (9) Defendant Snipes' Motion to Amend the Prior Scheduling Order (Doc. 253). The Government has filed responses to all of these motions (Docs. 249, 257, 259).

Upon due consideration, each of these motions is DENIED, (see Doc. 61), except for that portion of Defendant Snipes' Motion to Compel Immediate Disclosure of All Statements of the Defendants and Alleged Co-Conspirators Including Any Statements Attributed To Them As Alleged Co-Conspirator Statements, (Doc. 241), the Government is directed to furnish to the Defendant within ten (10) days of the date of this Order (if it has not already done so) any statement made by the Defendant which comes within the purview of Fed.R.Crim.P. 16(a)(1)(A) & (B). Defendant Snipes' Renewed Motion For Leave to File a Reply to the Government's Opposition to Snipe's Motions to Compel Discovery (Doc. 258) is DENIED AS MOOT.

IT IS SO ORDERED.
