

2.5 million pensioners now live below the poverty line with 10% of over 65's malnourished.

This is the shocking state after 11+ years of a Labour government. It is now thought that 90% of deaths attributed to an extreme winter are those over the age of 65 that amounted to 2,000 in 2007 and 260,000 since 1997!

Gordon Lishman, Director-General of Age Concern, said: "It is a national disgrace that pensioner poverty levels have begun to rise.

"Older people have been hit particularly hard as living costs have gone through the roof half of those affected by fuel poverty alone are pensioners."

Mervyn Kohler, a special adviser for Help the Aged, said: "The government should be mortified by the latest rise in pensioner poverty: in a twelve-month period, an additional 300,000 pensioners have been forced into poverty. On average that's around 822 pensioners each day.

"When older people live on a fixed income it is virtually impossible for them to pull themselves out of poverty. Pensioners often have to cut back on essential household items, just to survive. This is a disgrace.

"The government must take responsibility for the inequality so many older people face. Instead, each year the Treasury sits on more than £5bn of unclaimed benefits which should go to older people.

While this figure may make the chancellor rub his hands together with glee, this daylight robbery of older people must not be allowed to continue," he added.

These figures come at a time that the UK's contribution to the EU is growing to take account of the extra spending in the 'new' EU countries.

The UK is the second largest contributor to the EU, estimated at £30 million every day!

UKIP, who promised each pensioner £25 extra a week in its last election manifesto attacked the Government for its penny pinching, don't care attitude to pensioners.

The EU budget: A waste of money?

During the summer, behind the scenes, the EU's draft budget for 2009 was engineered, with minimum time for genuine scrutiny.

'Highlights': The budget is £116 billion, 3.15% above last year. Communications budget (promoting itself) is £171.6m, small beer compared to the £1billion for organisations actively promoting European integration including the European Movement and many others.

The lion's share goes to the European Commission, £95 billion. Of this, £35.75 billion goes to Agriculture and Fisheries. (The UK pays £374m in agricultural levies, more than any other member) £500m is spent on fisheries initiatives, purchasing International Fishing Agreements with non-EU countries and allowing Spanish and Portuguese fishermen to plunder the world's waters. Usually governments pocket this money leaving local fishermen, who can't possibly compete with sophisticated European competitors, without compensation.

Administration and EU integration budget gets a 5% increase to £64.2 billion, similar rises to the last three years. The real cost of

administration is carefully hidden by the creation of a series of quangos, budgeted separately.

There are too many organisations to list who take vast sums, examples include, the European Agency for Health & Safety at Work (£10.83m) and the European Foods Safety Agency (£58.3m). Too many others to list.

The generous 2009 EU staff pensions contribution is £970m. The EU budget also includes measures that are technically illegal as the Lisbon Treaty has yet to be ratified and has been rejected by the people of Ireland.

Finally, the budget for the European Parliament, Brussels and Strasbourg, is £1.25 billion. These figures have to be approved ... but only UKIP will vote against, so smile and pay!

£60 Fine for Number Plate

If you have a union flag, Cross of St George, on your number plate you are breaking the law and face a £60 fine.

Vehicles with a number plate displaying a national flag could also fail an MoT test. Jim Fitzpatrick, a transport minister told MPs of the restrictions when replying to a parliamentary question from Bob Spink, the United Kingdom Independence Party's only MP at Westminster.

According to Mr Fitzpatrick regulations which came into force seven years ago only allowed the display of the European Union symbol of 12 yellow stars on a blue background.

Mr Spink, the UKIP MP for Castle Point, questioned the issue after being contacted by motorists fined for displaying national flags.

Malcolm Hurst, UKIP candidate from Staffordshire said "Drivers do not know the regulations." He said: "No one believed it. This is outrageous."

DAWN OF THE ID CARD



The Government has revealed it will produce an initial run of 50,000 ID cards before ramping up production in 2009.

Foreign Nationals coming to the UK will be issued cards from November under the £4.7bn scheme.

The ID scheme will be rolled out over the next four years, starting with about 10million 'critical' workers – such as airport staff – in 2009, young people in 2010 and the rest of the UK public in 2011/12.

Home Secretary Jacqui Smith, unveiled designs for an identity card – with no sign of the union flag or mention of the word Britain.

The proposed ID cars carried a picture of a bull – in common with other European Union identity cards – as well as five stars drawn from the stars on the official flag of the EU.

Officials said the image of a bull represented the Greek myth in which Zeus turns himself into a bull and abducts Europa, a beautiful princess.



Jill Seymour, UKIP Parish Councillor and prospective Eu Election candidate, said it was bizarre that there were not more symbols of Britishness on the card, given that it will be used as a proof of residence.

Speaking at the recent UKIP Conference, Guy Herbert from the NO 2 ID campaign, thanked UKIP fulsomely for its support. The audience were staggered to learn that £100 million of taxpayer's money had already been spent by the Government on consultants.

He pointed out that passports were part of the scheme and he saluted the action of many people in renewing their passport early in order to give themselves a few more years of freedom from this perilous totalitarian tool.

UKIP have criticised the Home Secretary for her cynical use of people fear of terrorism and fear of mass immigration to sell the cards.

Once again the books don't balance

Marta Andreason, (pictured left) while working for the EU Auditors office exposed EU corruption and was subsequently sacked by Neil Kinnock for not being loyal to the EU.

Siim Kallas, the EU Commissioner for audit, has announced that the European Court of Auditors will not sign off the EU's 2007 accounts. Auditors will say they found only a slight improvement in the legality and regularity of payments between the financial years 2006 and 2007.

Speaking to MEP's, Kallas admitted that there were "real and unquestioned" weaknesses in 17 areas including research policy, the European refugee fund, structural funds external actions and rural development.

It strains credulity way beyond breaking point to ask anyone to believe that this record is just accidental. There is no way a company subject to normal regulation would survive this for more than two years maximum without being ordered to close.

With something like half of all EU income being unaccounted for—around £50bn per annum - something like £half a trillion must over the years have flowed to unaccounted destinations. What might they be?

The imagination runs riot. One can dismiss some of the theories as to where the money goes, but all the EU has to do to disprove these theories and show them to be as "off-the-wall" as we are asked to believe, is to actually come clean about it's books over the last 14 years. Let's not hold our breath.

ORWELLIAN PLANS FOR DATABASE OF PRIVATE COMMUNICATIONS

The government have announced that it is considering setting up a vast data warehouse of all phone and email traffic in the country, citing, as usual the "threat from terrorist plots" as the excuse.

The database would store all phone numbers dialled, websites visited and email addresses contacted by everyone in Britain.

UKIP's Jonathan Oakton criticised the plan as a "gross infringement on our liberty." He continued "How can we trust a government that has lost so much data in recent years?"

Roosevelt said, at the time of the Great Depression, that the only thing we have to fear is fear itself. In our more complex times, this isn't quite true. What we have to fear is who is going to claim credit for what has happened.

An example would be the recent unpleasantness over the banking system. Was it the European Union acting together that saved us all from disaster? That's certainly a claim that is in the air at the moment. Or was it in fact true that the European Union was part of the problem?

That's certainly the view of Tim Congdon, the financial markets expert within the party. When the problems with Northern Rock first started there was confusion over what could actually be done. Could we in Britain simply solve this problem ourselves? Or did we have to wait for instructions or permission from Brussels. Professor Congdon says that this uncertainty made the whole thing worse, leading to those shocking queues of depositors lining up to get their money. We could have solved it before then if we'd been allowed to simply get on with it ourselves.

You might also have seen the little pieces, hidden away, in the newspapers, after the more recent bailout of the banks. The EU "had approved" our actions. So kind of them, don't you think, after we were the country that paved the way to a solution. That we have their permission?

At first the problems were seen just as part of the Anglo Saxon economies, that it was just Britain and the US that were affected. This led to much sniggering on the Continent, comments about how we had brought it on ourselves with our rampant capitalism. This all rather died away when it was seen that the German, Dutch, Belgian and Spanish banks were all in

much worse condition than our own. They needed even more help.

There's another issue too. Over the regulation of banks. Yes, banks do need regulating, they cannot simply be left to themselves, but it does matter a great deal what sort of regulation there is. Our own regulation in the UK was always based on the law, of course, but it gave very wide discretion to those who were doing the regulating in the Bank of England. Problems would be solved by cracking a few heads together in the back rooms, the word of the Governor could close down market abuse immediately.

Then the European Union decided to take over this role of regulation. As always, they did it by giving us a set of minutely detailed regulations, worse than that, they insisted that each and ever comma and dot had to become law. So when the situation changed, as they always do, we didn't have any flexibility. We couldn't rely upon the wise men to tell us what to do; we could only do what was in the law. Even the EU has realised now that this won't work. Indeed they realised it over a year ago: but guess what? We're not going to see those changed regulations in the law until next year. That's just one of the problems that we have with the whole European legal system. It's insanely detailed and we can never change it fast enough, nor do we have the flexibility we need under it, to deal with emergencies.

But over and above all of this we've got the problem of who is going to claim credit for solving our recent problems? We can already see two entirely different stories being told. The first is that it was the nations, the individual governments, who were able to see what needed to be done and then did it. Certainly, they cooperated with each other, but then that's what nations do in times of trouble, they work with their friends and allies. I've no problem with that for it's happened often enough in our history, that we've worked with others to, say, defeat the Nazis, or beat Napoleon. But we've never been asked to give up our country, give up our freedoms, while we did so. No, we've remained accountable only to ourselves while we solved the problems we faced together.

But this isn't what the other story is about. In this other version, the problems that we faced, the others that we'll inevitably face in the future, can only be solved by more Europe, by more integration, by losing our country to the Federal Superstate. It doesn't matter that the EU didn't solve this one, that it was nations working together that did, it matters only how the story is told.

Those who fear what the future holds might want to give up our freedoms even more to the EU. But we believe and know that the British people do not need to fear, for we can and will as a free and independent nation deal with anything the world might throw our way. That's the message we want to get out to those who don't already know this, that while we will at times want to work with other countries as friends and allies, we don't have to give up our country for evermore to do so.

The European Commission is due to publish its health directive that has been postponed since December 07. It is expected that the Directive will make it easier for people to travel to get specific medical treatment in another EU country. However, left-wing Labour MPs are girding themselves for a rebellion over the issue which they say could spell the end of the National **Health Service.**

New Blow to British Haulier Industry

The EU is looking at the possibly of enlargement to North Africa. Foreign Secretary, David Milliband has already mooted the idea and is supporting Turkey's entry, who are already in negotiations to join. UKIP's Liz Hazel said "The EU juggernaut plows on and on, regardless. For our best interests we need to get off."

EU DRIVES UP SERVICING COSTS

The cost of motoring in the West Midlands is set to rise. It's been revealed that the EU intends to do away with an arrangement which allows motorists to have their vehicle repairs and servicing done by independent garages. As a result, drivers will be forced to use the manufacturer's more expensive dealership garages.

A report in *The Daily* Telegraph revealed a particularly vicious example of how unelected bureaucrats in Brussels will jack up the cost of motoring for British drivers. As is often the case with EU

legislation, the less well paid and those who cannot afford to change to a newer car will be hit hardest.

The arrangement now under threat is known as the "Block Exemption". In force since 2002, it obliges the motor industry to supply the parts and, more importantly, computerised information - to the smaller independent garages. Without it they would be unable to repair and service cars.

So if the Block Exemption goes, some 20,000 independent garages which charge average

hourly rates some 40% below those of their main dealer counterparts, would struggle to survive. Once the independent garages have gone, the main dealerships will be free more or less to charge what they like.

Eliminating the Block Exemption also means that the motor manufacturers will be free to withhold or charge what they like for any kind of computer code information. The resulting extra costs will eventually work their way through the entire industry costing every motorist more money to maintain their car.

RENEGOTIATION OF THE UK'S RELATIONSHIP WITH THE EU

That this House congratulates The Mail On Sunday on calling for the UK to renegotiate its relationship with the European Union; notes that its article of 20th July characterised the current relationship as 'fatuous Brussels' rules and inflexible British functionaries' and called this 'our national curse', stated that the current relationship 'repeatedly operates against the interests of this country's small businessmen, farmers, shopkeepers and consumers', concluded that no one 'can now seriously argue that Britain's long entanglement with the EU has been beneficial, successful or sensible', and called on Parliament 'to think seriously about freeing ourselves from this absurd, annoying organisation, and go back to making and enforcing our own laws'; and calls on the Government to respond appropriately to The Mail On Sunday's advice.

EQUITABLE LIFE PENSIONERS AND POLICY HOLDERS

That this House congratulates the Parliamentary Ombudsman on her report on Equitable Life; notes that UKIP policy is to fully compensate Equitable Life policyholders; further notes that many pensioners are passing away without seeing justice done; and calls on the Treasury to honour the Parliamentary Ombudsman's recommendations without further loss of time and immediately open negotiations with representatives of the Equitable Life policyholders.

During the Education Debate on the External SATs testing of children, he said "Let me spell out another sound UKIP policy on Education. introduced parts of the Constitution and Treaty anyway.

Lord Alloway proposed an amendment to the European
Union (Amendment) Bill 2008 which would basically say:
STOP! The British Government will operate only in

accordance with *current* treaties.

Lord Pearson of Rannoch, one of the UKIP Peers, spoke on this recently in the House of Lords:

"I fear this amendment will be of little value because for years the Government has failed to veto powers passing to Brussels that were clearly not envisaged by the existing treaties, and I do not suppose that they will start doing so now.

Examples are too many to mention, but a particularly good one appeared in a letter dated 30th March 2006 from Mr Barroso to an MEP. Mr Barroso was asked what the legal basis was for the new External Action Service. Mr Barroso replied that it was Article III-296(3) of the proposed constitution, which had been killed off by the French and Dutch nine months before.

When the MEP pointed that out, Mr Barroso agreed, but the project went ahead anyway in a legal vacuum. When I raised this in an Oral Question, the Government supported Mr Barroso.

Perhaps the Government has been at its most spineless in its refusal to veto the consistent abuse of Article 308 to extend Brussels' powers in areas that were not covered by the treaties.

I have raised this abuse several times in the past few years in Oral and Written Questions.

Article 235 in the original 1957 Rome Treaty was the clause which allowed Brussels to make minor tariff adjustments and so on in the then Common Market. One does not have to be a legal genius to see that Brussels can take power under this clause only in the course of the operation of the Common Market, but over the years, and especially since the collapse of the original constitution, Brussels has been put in charge of such initiatives as the grant of food aid to the least developed countries."

At this point Lord Pearson was rudely interrupted by the LibDem Lord Roper, suggesting, in error, that Brussels acts in the interest of the United Kingdom. Lord Pearson replied by saying:

"It is on proposals advanced in secret by the unelected Commission, passed in secret by the bureaucrats from the nation states, and then passed again in secret in the Council of Ministers. The point is exactly that: it bypasses our democracy – the House of Lords and the House of Commons completely."

The European Commission can decide what it wants to impose on Britain, how, and when and our elected British politicians have no power to stop it.

UKIP in the **European Parliament**



UKIP does not recognise the legitimacy of the European Parliament.

In 2004 however, 12 UKIP MEP's were elected to the parliament. They did not get elected nor do they attend to take part in the democratic sham that is the EU personifies in the parliament. Britain will in five years time experience prolonged power cuts; they could go on for years. Given the extent to which daily life now depends on computers, the effect of even the most temporary cuts could be catastrophic.

What are the reasons for the crisis?

- The wreckless depletion of our North Sea gas reserves, which the privatized power companies sold off to our European competitors at below market rates;
- The loss of 23 gigawatts (GW) of electricity generation capacity between now and 2020 due to the decommissioning our ageing nuclear reactors. These currently provide a fifth of the nation's electricity;
- An EU Directive requiring many existing coal and oil fired power stations to close. This will result in the likely loss of a further 12GW generation capacity.

Your government's solution to the 2013 energy crisis:

WRAP UP WARM!

Thanks to the policy shambles of successive UK governments, Britain faces an unprecedented energy crisis.

What are our options?

- Nuclear: Four new generation nuclear power plants are planned. These will be built by the French as a result of our government selling off Westinghouse, the only British-owned firm capable of constructing them. However, the new plants cannot be built in time to help fill the gap.
- Gas: One short-term remedy would be to build yet more gas-fired stations. Yet we are fast running out of our own reserves whilst gas prices are rocketing. This option would make us even more dependent on unstable foreign suppliers, including Mr Putin's increasingly belligerent Russia.
- Clean Coal: These power stations would have to be built in the teeth of the powerful but utterly misguided Green lobby. However, even though we still have more than 100 years of reserves, our own coal industry is so run down that we now import three quarters of the coal we use.

Despite this looming crisis, our ministers are still obsessed with the non-option of Mr Brown's £100 billion "green energy" plan aimed at meeting the EU's unattainable target of generating a third of our electricity from renewables by 2020.

Our present 2,000 wind turbines supply just 1.5 per cent of our power and even if Mr Brown's 7,000 additional turbines could realistically be built we would still fall far short of the EU target.

'Alternative' energy is not 100% reliable, so every single energy unit would require back-up from conventional power sources. In other words, the government's 'green' energy levy on the power companies is causing *your* bills to soar unnecessarily.

To avoid a major national crisis we must resort to the following emergency measures:

- keep current nuclear power stations running long past their present 'sell-by' date even though that's not a very appealing option...
- keep some of the coal-fired power stations in production beyond their scheduled closure date and launch a crash programme to build more as a temporary stop-gap. That would put us on a collision course with the EU...
- promote the efficient extraction of Britain's coal for use in cleaner coal-fired electricity generating plants.
- increase our physical links with friendly, non-EU countries, e.g., by building extra pipelines to import Norwegian oil and gas.

If we are to stop the lights going out in 2013 we must take matters into our own hands and act NOW.

'Never give up' Lady Thatcher advises UKIP Candidate



Lady Thatcher took time out at the recent Bruges Group 20th anniversary celebration of her Bruges speech to advise Nikki Sinclaire to "never give up".

Ms. Sinclaire told the former Prime Minister that she was standing for the UK Independence Party at the Euro-elections in June 2009. The Baroness responded "Good for you, never give up, no matter what happens, never give up."
