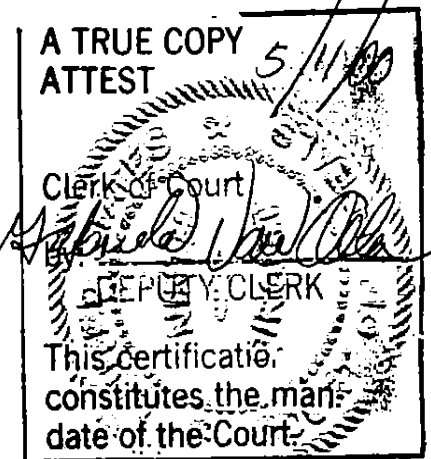

Margaret Elizabeth Broderick appeals pro se the district court's order denying her motion for reconsideration. We have jurisdiction pursuant to 28 U.S.C. § 1291 and affirm.

Because Broderick failed to present new evidence, establish clear error or manifest injustice, or identify an intervening change in the law which undermined the reasons for dismissing her action without prejudice, we conclude the district court did not abuse its discretion in denying her motion for reconsideration. See *School District No. 1J, Multnomah County, Or. v. ACandS, Inc.*, 5 F.3d 1255, 1262-63 (9th Cir. 1993).

We deny all pending motions.

**AFFIRMED.**
