COMES NOW, in the above styled action, Sovran Lineal Council for the :esens-tribus-people©TM; tribal agents for \*\*\*Little Shell Nation/Tribe©TM\*\*\* born upon the land, in peace, representing the real party of interest, competent, with firsthand knowledge of the facts, in Good Faith, in Honor, without argument, without prejudice, without displaced rights, representing the original creditor, secured party, original state, and original stockholder, acting for the :esens-tribus-people©TM; tribal agents for \*\*\*Little Shell Nation/Tribe©TM\*\*\* in and for a Lodgment of Acceptance of Oath of Office, acting for and on behalf of the Alleged Defendant's commercial interest;

- 1 Now comes the above named Sovran Lineal Council for the :esens-tribus-people©TM; tribal agents for \*\*\*Little Shell Nation/Tribe©TM\*\*\* acting for the aforementioned Alleged Defendants under a restricted appearance by visitation, humbly extending greetings and salutations for you and each of you gives notice of the Alleged Defendants' LODGMENT accepting the aforementioned named Governmental officers', agents and assignees; OFFER; Oath of Office in Admiralty and promises for proceeding for remedy of acceptance of: dishonor, supra protest for honor curing any defects; and that
- 2 The Defendant, further timely accepts, aforementioned named Governmental officers', agents and assignees,, Oath of Office in Admiralty, as an open OFFER for contracting by displaying a willingness for voluntary entering into an agreement in a way that would lead a reasonable person for understanding by making the representation that must have intended that the OFFER be acted on giving the offerees', agents and assignees', Alleged Defendants the power for creating a firm and binding private agreement between aforementioned named Governmental officers', agents and assignees' as the holder of the several offices of the UNITED STATES OF NORTH AMERICA=the UNITED STATES of AMERICA=the UNITED STATES=CANADA (sic), the STATE OF NORTH DAKOTA (sic), and the STATE OF SOUTH DAKOTA(sic); the defendants :zakiz-aanakwad©TM and :boa-kaa-konan-na-ishkawaaden©TM; and that
- 3 The Alleged Defendants, further accept the aforementioned named people's, Oath of Office in Admiralty as aforementioned named people, subscribed and swore, so help

me the Gitchi Manitou (Creator); and that

- 4 The Alleged Defendants further promises for proceeding with remedy of acceptance of: dishonor, supra protest for honor curing any defects ripening into a firm and binding contract for performing all the fiduciary duties and contractual obligations in the bargain for the successful completion of this contract, including but not limited in, aforementioned named Governmental Officers' sworn duty for upholding the Constitution of the STATE OF NORTH DAKOTA(sic) or the Constitution of the STATE OF SOUTH DAKOTA (sic) which may apply and the Constitution of the United States of America(sic) and the laws, statutes, rules, and Treaty's of the fore said which includes protecting all of the Alleged Defendants' unalienable rights resulting in the Offeror's, release from any liability; and that
- 5 Alleged Defendants further trust that you, the aforementioned named Governmental officers', agents and assignees', will be honorable, whose word is their bond; and that
- 6 Alleged Defendants further trust that you, aforementioned named people, will honor your private contract with the Alleged Defendants by keeping your sworn promises, and not allow any third-party agents, acting without delegated and regulatory authority for interfering in your duty with the Alleged Defendants; and
- 7 Please see attached request for Oath of Office and response by the chief clerk of Court stating that request for oath of office must be done by a formal request; A dated and signed request by a tribal/family member was given to the clerk of court on 08/10/2010 and she denied knowing any oaths of office on file and that she would notify the Chief Clerk of Court to provide them; the refusal by the United States District Court to provide the Oaths of Office upon request with a dated and signed (formal) request brings to mind that the court has impinged upon the alleged defendants rights and has committed Barratry and Champerty in their refusal to produce the Oaths of Office to their trustees :Zakiz-aanakwad©TM and :Boa-kaa-konan-na-ishkawaanden©TM; which could possibly result in injury to the alleged defendants and also in the supporting and/or promoting of the litigation of another, ie (the UNITED STATES of NORTH AMERICA=the UNITED STATES OF AMERICA=the UNITED STATES=CANADA); please see (Isabell

Enterjprises, Inc. V. Citizens Cas. Co of New York, D.C.Tex., 303 F.Supp. 549, 552); and also (Schnabel v. Taft Broadcasting Co., Inc., Mo.
