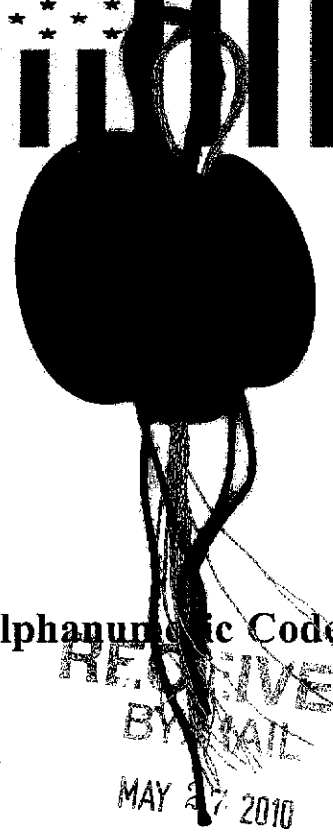

It appears by your actions, or your failure to make the corrections in this matter that you intend to ignore: the Real Party In Interest's declaration of peace; that the alleged Defendant is a living being and NOT an administrative agency or legal fiction; that the alleged Defendant is NOT an enemy combatant.

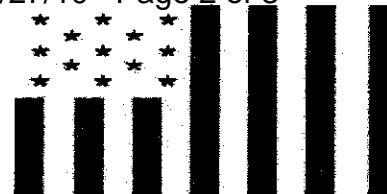
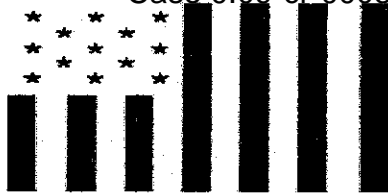

On March 6, 1933, President Roosevelt relied on Sec. 5(b) of the *Trading With the Enemy Act* as authority for his Proclamation 2039 which closed all banks for five days. This was clearly a time of financial crisis, not of war, and hence was not within the literal terms and purposes of the Act. More importantly, the Act was amended so as to *include* every citizen and every transaction and any form of national emergency. The Act was amended to make the sovereign people of America enemies of the state.

So, on March 9, 1933 President Roosevelt declared war on the sovereign people of America failing a valid Declaration of War, an act of treason against the people, to facilitate the pillage and plunder of the private property of the people.

**Insurrection** is described as a rebellion of citizens or subjects of a country [public servants] against its government, [the sovereign people of America].

**Insurgency:** an organized rebellion aimed at overthrowing a constituted government through the use of subversion and armed conflict.

While not every insurgency involves terror, most involve an equally hard to define tactic, **subversion**. "When a country is being subverted it is not being outfought; it is being **out-administered**. Subversion is literally **administration with a minus sign in front.**"

The administrative agents and agencies of the general post office known as the UNITED STATES, public servants charged with the administration of the affairs of the sovereign people of America, have fraudulently declared and are executing a war against the people, to pillage and plunder the private property of the American people through subversion. The administrative agencies of the UNITED STATES' subversion, "administration with a minus sign", under assumed Letters of Marque, against the American people constitutes **administrative piracy**. The American BAR Association membership card number represents an assumed Letter of Marque to facilitate the administrative piracy against the American people under assumed Letter of Marque by members of the private BAR Association.

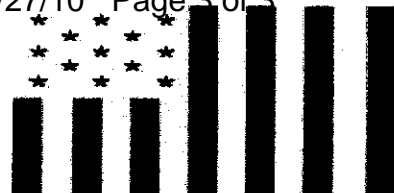
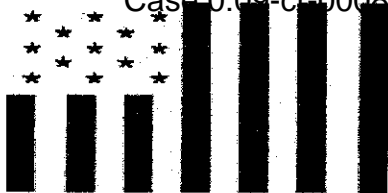
**The agents and agencies of the UNITED STATES are employing the use of terrorism by their armed jack booted thugs to enforce their insurgency and constitutes an armed insurrection and rebellion against the government of the united states of America. The acts and actions of the agents and agencies of the UNITED STATES in support of the insurrection constitute war crimes and crimes against humanity.**

## INSURRECTION

1. A rebellion of citizens or subjects of a country against its government.
2. The Constitution of the United States, art. 1, s. 8. gives power to congress " to provide for calling forth the militia to execute the laws of the Union, suppress insurrections, and repel invasions."
3. By the act of Congress of the 28th of February, 1795, 1 Story's L. U. S. 389, it is provided: Sec. 1. That whenever the United States shall be invaded, or be in imminent danger of invasion, from any foreign nation or Indian tribe, it shall be lawful for the president of the United States to call forth such number, of the militia of the state, or states, most convenient to the place of danger, or scene of action, as he may judge necessary to repel such invasion, and to issue his orders, for that purpose, to such officer or officers of the militia as he shall think proper. And in case of an insurrection in any state, against the government thereof, it shall be lawful for the president of the United States, on application of the legislature of such state, or of the executive, (when the legislature cannot be convened,) to call forth such number of the militia of any other state or states, as may be applied for, as he may judge sufficient to suppress such insurrection.
4. That, whenever the laws of the United States shall be opposed, or the execution thereof obstructed, in any state, by combinations too powerful to be suppressed by the ordinary course of judicial proceedings, or by the powers vested in the marshals by this act, it shall be lawful for the president of the United States to call forth the militia of such state, or of any other state or states, as may be necessary to suppress such combinations, and to cause the laws to be duly executed; and the use of militia so to be called forth may be continued, if necessary, until the expiration of thirty days after the commencement of the then next session of congress.
5. That whenever it may be necessary, in the judgment of the president, to use the military force hereby directed to be called forth, the president shall forthwith, by proclamation, command such insurgents to disperse, and retire peaceably to their respective abodes, within a limited time.


**Terms and conditions of contract:** Any act, actions and/or communication in this matter other than the dismissal of this action and/or your failure to vacate the restrictions on the liberties of the Real Party In Interest and make the return of the property to the principal, shall constitute execution of the contract and your stipulation to all terms and conditions set forth herein, to wit:

Upon execution of this contract Plaintiff consents and agrees to:


- a) The payment of an initial entry fee of \$20 million in gold coin for each count on the charging sheet;
- b) The payment of a fee in the amount of \$5 million in gold coin for each 'hearing' scheduled;
- c) The payment of a fee in the amount of \$1 million in gold coin for every communication;
- d) The payment of a fee in the amount of \$10 million in gold coin for taking possession, in any manner, of the body of the Real Party Of Interest;
- e) The payment of a fee in the amount of one (1) troy ounce of fine gold or gold coin for every 60 seconds the liberties of the Real Party Of Interest are restricted in any manner;
- f) Provide payment immediately upon creation of the fee;
